Performance Report for North Los Angeles County Regional Center

Every year, the Department of Developmental Services (DDS) contracts with regional centers in California to serve consumers and families. And, every year DDS looks at how well the regional centers are doing. This report will give you information about your regional center.

Last year, at North Los Angeles County Regional Center (NLACRC) we served about 16,990 consumers. The charts on page 2 tell you about the consumers we serve. You'll also see how well we are doing in meeting our goals and in fulfilling our contract with DDS.

At NLACRC, we want to improve every year, do better than the state average, and meet or exceed the DDS standard. As you can see in this report, we met or exceeded the DDS standard in all areas.

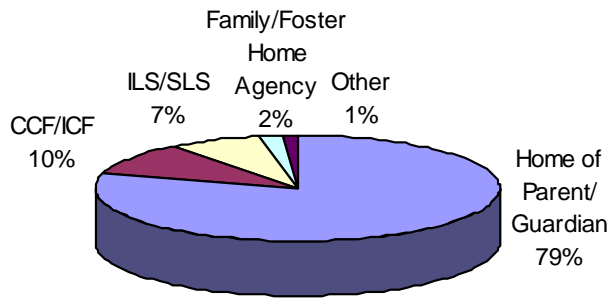

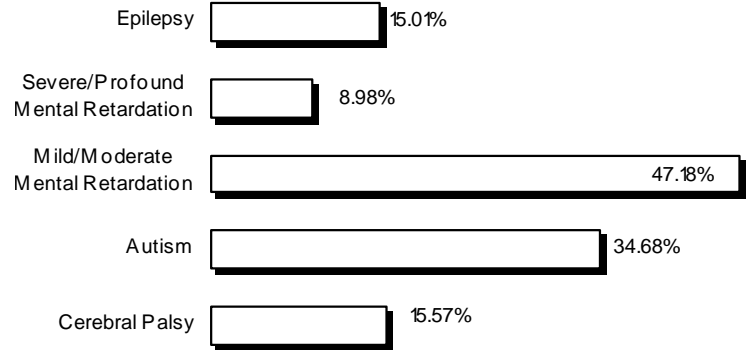
Who uses NLACRC?

These charts tell you about who NLACRC consumers are and where they live.

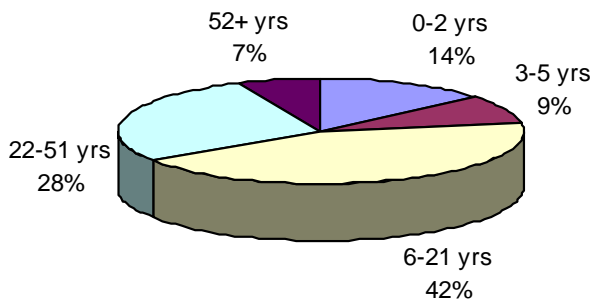
WHERE NLACRC CONSUMERS LIVE



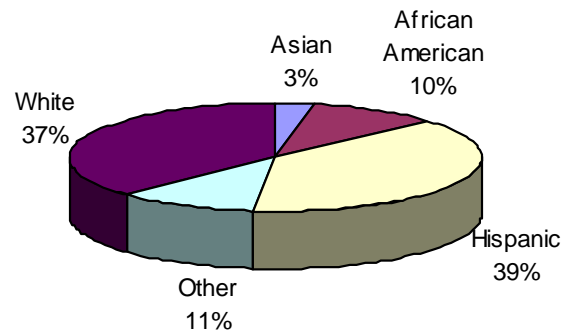
PRIMARY DIAGNOSIS OF NLACRC CONSUMERS

How well is NLACRC performing?

This chart tells you about 5 areas where DDS wants each regional center to keep improving.

The first column tells you how NLACRC was doing at the beginning of 2009. And, the second column shows how NLACRC was doing at the end of 2009.

To see how NLACRC compares to the other regional centers in the state, compare the numbers to the state averages (in the shaded columns).

1. The "last period" percentages for "IPP Requirements Met" and "IFSP Requirements" are for 2007.
2. The "current period" percentages for "IPP Requirements Met" and "IFSP Requirements Met" are for 2008. There was a decrease in percentage from 97.02% to 92.74% for "IFSP Requirements Met" from 2007 to 2008 due to difficulties in completing the initial evaluations for 2 out of 30 records. To address this, a plan of corrective action was submitted to DDS, and NLACRC has provided training to staff, and will continue to monitor for increased compliance.
3. DDS did not perform a Waiver review for IPP requirements or an Early Start review for 2009, therefore the percentages for "IPP Requirements Met" and "IFSP Requirements Met" remain the same from 2008 to 2009.

What about other performance areas?

In the future, we will measure how well we are doing in other areas, including:

- Increasing the number of consumers who work,
- Getting better pay for consumers who work,
- Making sure consumers get medical and dental services, and
- Meeting Intake/Assessment and IFSP timelines for children 0–3.
