# HUMAN INTEREST STORY SUBMISSION FORM SUBMISSION FORM - Continued

### Q: What do I need for NLACRC to accept my human interest story?

A: NLACRC can accept your human interest story if:

- You must send a completed Human Interest Story Submission Form;
- You must send all required consent forms (see below for more information);
- All consent forms must be signed by the person who has the authority to consent (see below for more information;
- Your human interest story must meet the Board approved social media posting criteria.

### What consents do I need to submit with my human interest story?

- Each person appearing in, who is heard in, or who is talked about in, a human interest story video, photo, or recording (as applicable) must complete and sign the "Authorization, Consent, and Release for Use of Name, Voice and Likeness."
- Each person who **took or made the picture, video, or recording** must complete and sign the "Photography/Video Release."

### Who can sign the human interest story consents?

- If you have a conservatorship or guardianship, or are a minor, you must make sure that you have the legal authority to sign the consent form to give consent. If you do not, your conservator, guardian, parent, or other legal representative (as appropriate) must sign the consent form to give consent.
- The person submitting the human interest story must make sure that all people who are in the human interest story, and all people who took the video, photo, or recording (or their conservator, guardian, parent, or other legal representative, as appropriate):
  - 1. Sign the correct consent form; and
  - 2. Have the legal authority to give consent.
